


SUBMISSION PROCESS

Section 14 of General Guidelines apply

All goalkeeper masks and helmet designs are to be submitted to the IIHF and the IOC for review prior to the Winter Youth Olympic.

01 PLAYER FRONT

Identification of the Manufacturer

- Jersey | Warm-up Jersey One Identification of the Manufacturer [per clothing item will be permitted, to a maximum size of 30cm².
- Pants One Identification of the Manufacturer [per clothing item will be permitted, to a maximum size of 30cm².
- Collars and roll necks If a roll neck or polo shirt is worn, no Identification of the Manufacturer may appear on the collar or on the neck.

Only one Identification of the Manufacturer will be allowed: it may be situated on the chest, with a maximum size of 30 cm².

 Hockey socks | Socks tape No Identification of the Manufacturer may appear on these items.

Sports Equipment

- Helmet | Head protector (full face mask) May carry the Identification of the Manufacturer as displayed on products sold through the retail consumer market at least six (6) months before the Winter Youth Olympic Games.
- Facial protection One Identification of the Manufacturer [per item will be permitted on each side, with a maximum size of 6cm² on player facial protection
- Neck protection May carry the Identification of the Manufacturer as displayed on products sold through the retail consumer market at least six (6) months before the Winter Youth Olympic Games.

- Gloves May carry the Identification of the Manufacturer as displayed on products sold through the retail consumer market at least six (6) months before the Winter Youth Olympic Games.
- Hockey stick

May carry the Identification of the Manufacturer as displayed on products sold through the retail consumer market at least six (6) months before the Winter Youth Olympic Games.




